





#### **Location and Market Attributes**

New retail mixed use opportunity in rapidly growing Lancaster County, Pennsylvania. Located on Lincoln Hwy East in Lancaster, the site is the key entry point to one of the region's strongest retail, restaurant and hotel corridors in Lancaster and Central Pennsylvania, and is situated within the heart of Lancaster County's tourism drivers.

In the heart of Pennsylvania Dutch Country, Lancaster County draws 8.34 million tourists and provides \$1.97 Billion of commerce annually to the local economy visiting (to just name a few) the Amish Country, Sight and Sound Theater, American Music Theater, Historic Lancaster City, Wheatland - the home of James Buchanan, Dutch Wonderland Theme and Waterpark, and Outlet Shopping at Tanger and Rockvale, where shoppers enjoy 0% sales tax on clothing.

Tourism Economics estimated visitor spending growth for 2015 and conducted a benchmarking analysis across multiple measures of tourism activity, supporting the following findings.

• Visitor spending in Lancaster County increased 2.8% in 2015, from \$1.92 billion to \$1.97 billion. The estimated number of visitors, including both day and overnight visitors, increased 2.3% from 8.15 million to 8.34 million, with average spending per visitor of \$237. International visitors accounted for approximately \$44.0 million of total visitor spending in 2015, an increase from approximately \$42.4 million in 2014. Since 2005, total visitor spending in Lancaster County has increased by more than a third (37.4%).

As shown in the above table, this annual spending activity is estimated to support 24,031 total jobs in Lancaster County, including 15,967 direct tourism industry jobs. Total employee wages and other labor income are estimated at \$801.1 million, including \$417.2 million of direct labor income. These 2015 impacts represent gains ranging between 6.7% to 16.4% relative to 2011.


#### The following recaps the 2015 economic impact of tourism in Lancaster County:

- An estimated 8.34 million visitors to Lancaster County directly spent \$1.97 billion in 2015, creating a total tourism impact of \$2.64 billion in the county.
- Visitor spending supported more than 24,000 county jobs, including approximately 15,970 direct tourism industry jobs, which makes tourism the fifth largest non-agriculture private sector employer in the county, accounting for 1 of every 15 such jobs.
- \$193.9 million in state and local taxes
- \$190.1 million in federal taxes


